This is because we are more than a nation; we are the children of Israel, the descendants of the same parents and that makes us a family.

As you know, Pesach is a very costly holiday. There is an age-old custom to help others in our 'family', both local and abroad, to off-set the costs of celebrating the holiday. I encourage you to continue this beautiful tradition by contributing to one of the many fine charities that exist. I also authorize Rabbi Yisrael Motzen to lease all or any property, in the specific location wherein the above mentioned Items owned by me may be found as he deems fit, and for such a time which he believes to be proper. I also give said Rabbi Yisrael Motzen full power and authority to appoint a substitute in his stead with full power to sell and lease as provided herein.
